RESOLUTION 1-2011: TRANSFER OF PROPERTY IN SOMERSET, KENTUCKY

The Cincinnati, New Orleans and Texas Pacific Railway Company (CNO&TP) purchased property in Somerset, Kentucky, for additional siding and new crew quarters. The property was purchased in order to add it to the property already owned by the Board of Trustees of the Cincinnati Southern Railway (the Board) and leased to the CNO&TP. As construction of the siding and crew quarters are complete, the CNO&TP is ready to transfer the property to the Board. Ms. Carman passed out proposed Resolution 1-2011, that authorizes Mr. VanderLaan to execute any and all documents on behalf of the Board to effect a transfer of property from the CNO&TP to the Board. Mr. Kilcoyne moved to approve. Mr. Sylvester seconded. Unanimously approved.

RESOLUTION 5-2011 - SALE OF TEMPORARY CONSTRUCTION EASEMENT IN LEXINGTON, FAYETTE COUNTY, KENTUCKY TO THE KENTUCKY TRANSPORTATION CABINET

In conjunction with the construction of the noise wall mentioned in Resolution 4-2011, the Kentucky Transportation Cabinet has asked to purchase a temporary construction easement on the Trustees' property in Lexington, Fayette County, Kentucky for a noise wall. Mr. Kilcoyne moved to pass Resolution 5-2011, which authorized Mr. VanderLaan to sign a deed for the temporary easement to the KTC. Mr. Sylvester seconded. Unanimously approved.

PARALLEL INFRASTRUCTURE

Certain Board members received a letter from Parallel Infrastructure offering certain services to maximize the earnings potential of the line. The Board asked Ms. Carman to review the lease to determine whether a discussion with Parallel could be fruitful.

INSPECTION TRIP
